PUBLIC PARTICIPATION TO REVIEW CIDP 2018-2022 STATUS & FINANCIAL YEAR 2022/2023 BUDGET - FOCUSING ON DEVELOPMENT AT WARD LEVEL

Pursuant to the provisions in the Constitution of Kenya 2010, County Government Act 2012 and Public Finance Management Act 2012 requiring openness and accountability, the County Government of Narok hereby invites all stakeholders including institutions, private sector nongovernmental organizations and individuals, to submit proposals on development priorities and own source revenue enhancement strategies, for consideration in the preparation of a Supplementary for FY 2022/2023 budget. The supplementary budget is intended to promote citizen engagement in identify projects that will address the felt needs at the smallest units of community and achieve equitable allocation of development budget to all Wards.

The submissions should incorporate viable options for accelerating and sustaining inclusive growth for socio-economic development. The stakeholders are advised to pay attention to the development agenda in the manifesto of H.E the Governor. They are also to focus on multi-year (ongoing) programmes/projects in Narok County Integrated Development Plan (CIDP 2018-2022) and re-prioritize the projects in the fifth and final year of the plan, accessible at www.narok.go.ke. The content of the proposals should feature practical solutions for combating current and emerging risks posed by climate change and pandemics. Further, the submissions should be specific on proposed priorities and be supported by a statement on the issues to be addressed and should provide a clear justification.

To facilitate timely consultation and adequate considerations, your proposals should be delivered in hard copies to Narok County Headquarter so-as-to reach the undersigned not later than **24**th **October 2022.** Soft copies should be delivered through our email: economicplanning@narok.go.ke

All stakeholders are also invited to attend public participation for on 17th, 18th, 19th, 21st, 22nd, and 24th October 2022 at various venues as shown in the schedule below. The fora will also serve as platforms to review the implementation status of CIDP 2018-2022 programmes/projects and collect views on decentralized structures for Ward level development initiatives.
